### SUSR STATUTORY GUIDANCE

- The SUSR team are working closely with key stakeholders to address recent comments on the draft Statutory Guidance. All feedback will be reviewed ahead of the next Steering Group meeting.
- A joint Steering Group and Legal and Governance meeting has been scheduled for the 14<sup>th</sup> of February to review the final draft of the guidance.

### BACKGROUND

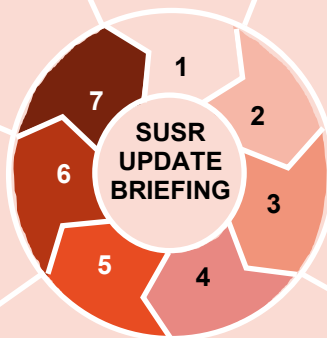
Create a single review process where a multi-agency approach is required, incorporating the following review processes Adult Practice Review; Child Practice Review; Domestic Homicide Review; Mental Health Homicide Review; Offensive Weapon Homicide Review. The final report is then used to inform professional practice via the Wales Safeguarding Repository.

### PROGRESS TO DATE

- As you will now be aware, the Learning and Training, Policy and Process, Wales Safeguarding Repository and Mental Health Homicide Task and Finish groups are closing. If you are a member of one of these groups and would like to still have some involvement with the development and implementation of the SUSR, please email to join our **Stakeholder Reference Group (SRG)**.
- The inaugural SRG meeting will be held on the 26<sup>th</sup> of January.
- The Dyfed Powys Police and Crime Commissioner now has a seat on the Mid and West Wales Regional Safeguarding Board to strengthen links between community safety and safeguarding across the region.

### WALES SAFEGUARDING REPOSITORY

- Discussions have been held around using the Stakeholder Reference Group to test the Repository. Please get in touch if you would like to be a part of this testing.
- The WSR team are currently reviewing the SUSR Report template to ensure its compatibility with the Repository.



### LEARNING & TRAINING

- Work continues to plan the next steps of the development of the SUSR Training materials with Mid and West Wales Regional Safeguarding Board.

### MENTAL HEALTH HOMICIDE

- This group has reviewed the Statutory Guidance to ensure that the Mental Health Homicide Appendix is still up to date.

### POLICY & PROCESS

- The final draft of the SUSR Report template is now being finalised with key members of this group alongside the WSR team.

### OFFENSIVE WEAPONS HOMICIDE

- Training has commenced for the Offensive Weapons Homicide Review pilot.
- The OWHR team will be linking in with Regional Safeguarding Boards to share information about the OWHR process.

### LEGAL & GOVERNANCE

- This Task and Finish group will meet with the Steering Group to review the SUSR draft Statutory Guidance before it is submitted for formal Welsh Government consultation.
