#### SUSR MINISTERIAL BOARD MEETING

- The Board was given an update on the WSR and demo – you can view this <u>here</u>.
- A presentation was given with key issues arising from the SUSR Statutory Guidance consultation.
- Actions arising from the meeting include an options paper to go to the Deputy Minister for Social Services on capacity and funding. The SUSR be presented to the Partnership Council for Wales as good practice. For information sharing – partners to use the waymarking within the revised SUSR Statutory Guidance, and the escalation process through the Support Network.
- The Wales Safer Communities Board presented a paper outlining issues with the Home Office Quality Assurance Panel. Action will be from the DMSS to send a letter to the appropriate Home Office Minister regarding these.

### BACKGROUND

Create a single review process where a multiagency approach is required, incorporating the following review processes Adult Practice **Review; Child Practice Review**; Domestic Homicide Review: Mental health Homicide Review; Offensive Weapon Homicide Review. The final report is then used to inform professional practice via the Wales Safeguarding Repository.
