How can they be improved?

There was a shortage of acknowledgement around victims and the possible impacts of the action plan:

- There is no mention of domestic abuse perpetrators or those where there may be other forms of abuse where the perpetrator needs to be removed with immediate effect for the protection of the victims. Therefore, risking perpetrators using that they cannot be made homeless as justification to remain where they are.
- Refuge provision is mentioned, but it was not clear in the action plan that part of the emergency safeguarding of victims and their families should take precedence, where remaining in the home is not possible and would carry risk of continued harm.
- The ending of all evictions causes concern from a community safety perspective. Research carried out by the Wales Safer Communities Network with the Anti-

Social Behaviour (ASB) Practitioners Network, identified that as evictions are the final tool/power that its removing during the pandemic increased the escalation of ASB and additional trauma for victims. Some of the victims can't move due to disabilities and requiring house adaptations and the policy of no evictions led to additional problems and issues.

We are concerned by the lack of acknowledgement around community safety, including the lack of mention of community safety partnerships. A number of the different elements mentioned have direct engagement or crossover with community safety and to not include it is to risk silo working.

Whilst policing is not devolved there are a number of areas where there is a crossover and where engagement and working with the police forces in Wales will be key. This could be strengthened in the action plan.

In principle we agree, but we would want ASB, all forms of abuse and hate crimes to be factored in.

We are aware of staff shortages across all sectors at the current time, and are increasingly seeing a lack of Mental Health services being raised as an issue by Community Safety Partnership partners and Registered Social Landlords for delivering safer communities. A joined up approach for mental health services across all areas of work that is holistic seems to be an increasing need.

The need for safe homes seems to be missed in the action plan. If housing or homes are provided that are not fit for purpose then the risks for health, personal and community safety and community cohesion and the impact on crisis services in those areas could be increased.
