



### **Good Practice**

The following good practice has been shared with the Co-ordination Hub from an experienced Chair/Reviewer.

During the Review the Chair met with the family on a number of occasions. Following each meeting the Chair wrote a letter to the family which outlined what had been discussed during that meeting and confirming next steps. These letters were then sent to the family by the Business Unit. This meant that family expectations were managed throughout and they had a written record to refer to in case they forgot anything that was discussed during the meetings. Just remember; what works for one family may not work for another, tailor your approach to the needs of the family.
