





FAQs

• Care Cards

Q. Who would be the best point of contact to obtain a supply of the care cards so that South Wales Police in Swansea can assist with the distribution?

A. James Dunn responded to say that once the care cards have been formally approved within South Wales Police, they will be distributed widely. There has been a significant number printed by Cardiff University's Students Union, who are keen to support the initiative. The care cards will be distributed to individual venues and will also be kept at Cardiff Central Police Station. The distribution phase is still being finalised. James welcomes conversations about sharing the cards further than South Wales, and sees no issue with sending the PDFs to Local Authority colleagues who can print them and distribute locally.

Q. Do the care cards have the details of Victim Focus to ensure that victims can seek support?

A. James Dunn confirmed that the care cards should have the Victim Focus details on them, and also that there are QR codes on the cards which link to a website hosted by Cardiff and the Vale University Health Board which has links to various agencies who provide further information, help and support.

Q. If the care cards were adopted as standard, could Welsh Government provide funding for these materials to be distributed across Wales?

A. Welsh Government will look to see what can be done through the campaign communications budget regarding distribution of the care cards across Wales.

ACTION: James Dunn to arrange for the care cards to be sent to Paul Webb in Welsh Government for further consideration.

FAQs

Q. There should be a consistent approach from all Health Boards and Emergency Services, so that regardless of where you are you receive the same level of support if you feel that you have been a victim of drinks spiking. Is there a way to bring those medical provisions together to ensure there is a consistent approach in Wales?
A. James Dunn responded that he is in contact with colleagues from across Wales and across the UK. If something looks like it works, there is a high chance that other Health Boards will get on board. There is an ongoing conversation about who would be best to drive this e.g. South Wales Police, Public Health Wales, etc.

• Data

Q. A student from Swansea University asked about the lack of clinical codes used for capturing spiking admissions and asked Welsh Government if this was something they were looking into for health

care data collection on spiking.

A. James Dunn explained that, in terms of ED data, the numerous computer systems used by medical services do not currently allow for this to be a practical option. In Cardiff, there is better data capture due to the Violence Reduction work from John Shepherd but there remains the issue of under reporting by the public.

A. Paul Webb also commented that one of the actions from the draft VAWDASV Strategy is to establish a central repository of knowledge to coordinate all of the sources of information and evidence that is relevant in order to identify what do we know about the different parts of the wider VAWDASV agenda.

It was confirmed that Welsh Government officials would be interested in picking up conversations with Health colleagues as to how prevalent the issue is and what is the nature of this issue.

ADDITIONAL COMMENTS & INFORMATION

A delegate commented that the public narrative around spiking is focused on the use of illicit drugs and "stranger danger". However, it should reflect what has been discussed today, which is that the use of alcohol could also be a form of spiking, and that it can happen with someone that you know.

The delegate added that if work is going to be taken forward looking at data collection it would be really useful to identify the perpetrators of spiking, and their relationship to the victim.

Another delegate suggested that Jon Drake may wish to consider an All Wales approach being tabled at the next Policing Partnership Board for Wales.

ACTION: Emma Thomas to discuss with Jon Drake and Paul Morris about the possibility of an All Wales approach to responding, and communications in response to, Spiking.

SAFETY STANDARDS FOR NIGHTLIFE SPACES



Policy First

Enact a policy for dealing with and preventing sexual harassment and assault. Make sure customers know about it and staff can follow it. It should be published on your website. Good Night Out offers template policies as part of our accreditation programme.



Skill Up

Make sure your team has the knowledge, skills and confidence to respond to disclosures in a compassionate way that prevents further harm. This is best achieved through specialist, interactive training that effectively challenges the misinformation about sexual violence.



Start the Conversation

Let your customers know about your values, both on-site and online. Demonstrate that there will be consequences for inappropriate behaviour in your space, that reporting is encouraged and that those who speak up will be believed, supported and listened to.



Keep a Record

Staff should know the location of your incident book and how to use it. Ask your licensing officer for advice on information sharing and making reports. Find out where your local sexual assault support service and signpost to them.



Be Practical

Where can you designate a 'quiet/er space'? Find somewhere people can go for a time out, chill out or talk through an incident away from the main area and make sure staff know of it. Do staff know your policy on booking a taxi for a customer? Make it clear to all.



Champion Access for All

Nobody should feel excluded from nightlife because of who they are. Offer disabled and gender neutral bathroom provision on site, or make clear that you are committed to working towards this. Undertake an 'access audit' with our partners at **Attitude is Everything**.



Promote Consent Culture

No single premises can end sexual harassment and assault by itself, but nightlife spaces have a huge role to play. How can your bookings, lineups, design, marketing and language evolve to create a more inclusive and welcoming environment for every single visitor?
